Children aged 0-17 years who are eligible for the **Child Dental Benefits Schedule** can access general dental care at any public dental service and will receive the next available appointment. See page 2 for more details.

## **Types of services**

#### **Public dental services**

Eligible Victorians can access free or subsidised dental care at the Royal Dental Hospital of Melbourne or Community dental agencies across Victoria. Services include general, emergency, denture, and specialist care.

### Community dental agencies

Community dental agencies are located throughout Victoria and are typically part of a multi-disciplinary community health service that offers a wide range of care.

#### **Private dental clinics**

Privately owned clinics set their own fees, which vary by clinic and type of care.

## **Types of care**

#### General care

General dental care includes things like oral examination, x-rays, oral health advice, scale and cleaning, extractions, fillings and fissure sealants.

### **Emergency care**

A dental emergency could be swelling of the face, trauma to the face, bleeding from the mouth that will not stop, an ulcer or sore in the mouth that has not healed, severe mouth pain that prevents sleep, tooth fracture or an exposed tooth nerve.

Eligible Victorians can access emergency dental care at public dental services at any time. Non-eligible Victorians can also access emergency care at RDHM if they meet specific clinical criteria.

#### **Denture** care

Denture care includes complete or partial upper and/or lower dentures.

### Specialist care

Specialist care includes paediatric dentistry, special needs dentistry, oral medicine, oral and maxillofacial surgery, orthodontics, periodontics, endodontics and prosthodontics.

To access public dental specialist care, a general course of care *must* have been completed and a written referral provided by the treating dental practitioner.

## Fee schedule

Fees are set by the Department of Health, but they may vary between community dental agencies. Contact your local community dental agency for details. Fees are updated annually.

Fees for specialist services depend on the treatment. They will not exceed \$378 for a course of care.

Below is the approximate fee schedule for different types of care in public dental services. Some people are exempt from paying fees. Refer to fee-exempt section of the guide (page 1).

People facing financial hardship may be eligible for fee exemptions, as assessed by dental agency staff.

# **Child Dental Benefits Schedule (CDBS)**

The CDBS covers the cost of basic dental services for children aged 0–17 years. Children are eligible if their family receives Family Tax Benefit Part A or other relevant payments.

CDBS can be used at all public dental clinics and there are no out-of-pocket costs. Not all private dental clinics offer CDBS and those who do may also charge additional gap fees.

The CDBS covers check-ups, cleaning, fissure sealants, fillings, x-rays, extractions, and root canal
